98.9 The Rock 2021 Harley-Davidson / Trip to Sturgis Giveaway Official Contest Rules

These contest rules are specific to the above contest conducted by Audacy Kansas, LLC d/b/a KQRC-FM 98.9 The Rock (the "Station"). Except to the extent specifically set forth below with respect to this specific Contest, the Station's general contest rules apply to this contest as well. How to Enter

On Monday, July 26, 2021, up to ten (10) On-Site QR entries will be randomly selected from all On-Site QR entries received to win a Qualifying Prize (as described in Section 6 below) and be qualified for the chance to win the one (1) Grand Prize (as described in Section 7 below) in this Contest, subject to confirmation of eligibility and compliance with these Contest rules (each, an "On-Site QR Qualifier").
- iii. All locations on where displays are located to register will be listed on the Harley Trip to Sturgis contest page on www.989therock.com.
- iv. There will be up to, but not more than, seven (7) Worth Harley-Davidson On-Site Qualifying Prize Winners and up to, but not more than ten (10) On-Site QR Qualifying Prize Winners in this Contest, collectively referred to herein as the "On-Site Qualifiers". There will be up to a total of seventeen (17) On-Site Qualifiers in this Contest.
- 3. All Call-In, Text and On-site Qualifiers are collectively hereafter referred to as "Qualifier(s)". No person may be a Qualifier in this Contest more than once, regardless of the mode of entry (only the first chronological qualification will count, any subsequent qualifications will be deemed disqualified).
