

HI-LO HO HO HO Contest Rules

These contest rules are specific to the above contest conducted by Audacy California, LLC d/b/a KUDL-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. Entry/Winning

1. No purchase or payment of any kind is necessary to enter or win the Hi-Lo Ho Ho Ho (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. Weekdays (excluding holidays) from November 15, 2021 through December 10, 2021, between 6am and 7pm, listen for the recorded “cue to call” to try to “Pick Your Hi-Lo Ho Ho Ho Number”. When the “cue to call” is announced, caller 17 to the Station’s contest line at (916) 766-1065 will be given the opportunity to select one of Hi-Lo Ho Ho Ho numbers by selecting a number between 1 and 106. There will be a total of 14 winning numbers will be available in this Contest and each will be assigned a number between 1 and 106 prior to the commencement of this Contest. If a caller selects a number that was previously selected by another caller in this Contest, that caller will not be a winner in this Contest. If the caller selects a number that has not been selected by a previous contestant in this Contest, that person will win the prize assigned to that number, subject to verification of eligibility. There will be no less than 4 Contest plays per contesting day.
 - a. Only calls received at the preceding phone number are eligible to participate in this Contest.

Prize(s)
