

Magical Reveal Game Contest Rules

These Contest rules are specific to the above Contest conducted by Audacy California, LLC d/b/a KUDL (the “**Station**”). Except to the extent specifically set forth below with respect to this specific Contest, the Station’s general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station’s general contest rules are available on the contest page on the Station’s website at www.endonline.com. **As a preventative measure in light of the COVID-19 (Coronavirus) pandemic, copies of the specific Contest rules and the Station’s general contest rules will not be available at the Station’s studio. To the extent the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.**

Entry/Winning

1. No purchase necessary to enter or win the Magical Reveal Game Contest (the “**Contest**”).
2. To enter, listen to the Station each weekday starting on May 9, 2022 and ending on May 27, 2022 at approximately 7:00am (PT), 9:00am (PT), 3:00pm (PT), and 5:00pm (PT), each time a “**Contest Play**”, for the Station to solicit for listeners to call in and be the 17th caller to 916-766-1065 to play the Magical Reveal Game. The Station representative will then ask the designated caller to guess the number of one (1) concealed square on the official “**Game-Card**”. There will be a total of three (3) Game-Cards during the Contest; each Game-Card will contain a total of one-hundred (100) numbered squares with five (5) winning squares pre-hidden. The 17th caller to get through to the Station contest line after each cue to call airs will only receive one (1) opportunity to guess one (1) numbered square on the Game-Card. The Station will play the sound concealed behind the guessed square and if the one (1) square selected by the designated caller reveals the designated Disneyland sound of the winning square, that caller will win one (1) Prize (*as described in section 8 below*), upon verification (each a “**Winner**”). If the sound concealed behind the guessed square is the sound of a buzzer, that square will be concealed again and that caller will not win a prize. The Contest will be played up to four (4) times per weekday during the Contest. Each Game-Card will be active for the sooner of one (1) week (Monday-Friday) or when all five (5) winning squares are revealed, whichever happens first. A new Game-Card will start either after all five (5) winning squares have been revealed on a Game-Card or at the beginning of a new week (Monday), even if all the hidden winning squares are not revealed during a week.
 - a. **WARNING: ONLINE LISTENERS TO STREAMED BROADCASTS MAY EXPERIENCE A LAG IN TRANSMISSIONS DUE TO BUFFERING LIMITATIONS. LISTENERS SHOULD NOT RELY ON STREAMED BROADCASTS FOR THE CUE TO CALL IN AND BE THE 17TH CALLER.**
 - b. **CALLS TO OTHER STATION PHONE NUMBER(S), OTHER THAN THE ANNOUNCED CONTEST LINE NUMBER(S), INCLUDING THE STATION’S GENERAL/MAIN NUMBER, WILL NOT BE ACCEPTED.**
 - c. Listeners are encouraged to keep track of the items associated with selected squares previously guessed by other designated callers. All participants in this Contest understand and agree that Station has no obligation, liability or responsibility whatsoever if listeners obtain information from third parties such as other listeners (*i.e., calling a third party, etc...*).

- d. Station may, but shall not be obligated, to limit the amount of time in which a caller may guess their one (1) numbered square.
 - e. All decisions by Station in this Contest are final and may not be appealed.
3. There are three (3) Game-Cards in this Contest and this Contest will end at the earlier of (a) when all five (5) winning squares have been revealed by a selected caller on each of the three (3) Game-Cards or (b) May 27, 2022 at 7:00pm (PT). **THIS CONTEST WILL END AS SOON AS ALL THE WINNING SQUARE PRIZES HAVE BEEN AWARDED (A TOTAL OF FIFTEEN (15) PRIZES HAVE BEEN AWARDED).**
 4. Listeners are encouraged to keep track of the designated Disneyland sound associated with selected squares previously guessed by other designated callers. The Station will only post an example Game-Card on its website. Station representatives may post examples of revealed squares on its website (or through other media that link to its website) within one (1) business day after a winning square has been revealed (for example, the virtual online Game-Card will simply show the numbered boxes of each Game-Card 1-100 but when the first winning square has been revealed a Disneyland ticket photo will replace the number on the winning square). Listeners are encourage to listen to keep track of the guesses by the designated callers in order to increase their chances of winning if they later becomes a designated caller. Guessed numbers that were already revealed will not be available on the Station website nor by calling the Station. However, the Station cannot prevent others from distributing that information and all participants understand and agree that Station has no obligation, liability or responsibility whatsoever if people obtain information from third parties such as other listeners (i.e., calling a third party), etc.
 5. Listeners may (but are not required) to obtain/download a copy of each official Game-Card starting on May 2, 2022 through May 27, 2022 (or earlier if the Contest ends prior to May 27, 2022) by visiting the Station's web page at <https://www.endonline.com>. Listeners are not required to register or download a Game-Card or be an E-Club member in order to play or win this Contest. Listeners can play along by creating their own Game-Card or just keeping track of previously selected spaces in their minds.
 6. The Station may (but is not required to) distribute hints or even disclose which squares have previously been revealed to its E-Club members (by email or otherwise), to its Twitter/Instagram/Facebook followers or on-air (whether or not announced in advanced that hints/information will be provided at a set time) from time to time during the Contest. If Station elects to distribute any of this additional information/clues, it will be the sole responsibility of the participants to join the associated clubs or listen during the associated radio shows. Please note that new E-Club members may be subject to up to 2 business days after they opt-in/register to become an active/confirmed members entitled to receive emails and other Contest information.
 7. Once a listener becomes a Winner, that listener is ineligible to play or win again. All callers who do not guess a winning square are eligible to attempt to be the designated caller again at a later game play date/time. Listeners may only be a Winner one (1) time in this Contest.

Prize(s) Description:

8. The up to fifteen (15) winners in this Contest will each receive one (1) four (4) pack of two (2) day, one (1) park per day, tickets to Disneyland Resort or Disney California Adventure (the “**Theme Parks**”) valued at approximately \$1020.00 and courtesy of Disneyland Destinations, LLC (each, a “**Prize**”). Theme Park tickets must be used prior to June 15, 2023. Terms and conditions as set forth herein and on the Theme Park tickets shall apply. Theme Park tickets may not be sold, transferred for commercial use, or redeemed for cash. No substitutions. An inability to use any tickets will result in forfeiture of such tickets. Block-out dates apply. No extensions will be granted. Both a Theme Park ticket and separate Theme Park reservation for the same park on the same date are required for park entry for the winner and each Guest. Theme Park reservations and tickets will be required for each day of the visit and must be obtained before visiting. Park reservations are limited and subject to availability. Park reservations do not guarantee park admission or access to any experience, attraction, or offering. Winner and Guests should visit [Disneyland.com/updates](https://disneyland.com/updates) to make park reservations and to learn about important details to know before visiting the Disneyland Resort. Prize will not include the following: transportation to/from the Theme Park; insurance (health, travel, medical); parking fees; hotel accommodations; food or beverages; merchandise, souvenirs; incidental expenses; local or long distance telephone calls; tips, gratuities, service charges; any taxes; or any other charges not explicitly included herein. Certain Theme Parks, hotels, restaurants, attractions, experiences, services and other offerings may be modified, limited in availability and capacity, or be closed. There may be specific state or government health agency instructions, guidelines and requirements for all visitors to the Theme Parks. The winner and their guests are solely responsible, at their own cost, for staying updated on and complying with any of the latest restrictions and requirements that may be in place for travel to and visiting the Theme Parks. Such restrictions and requirements are subject to change. A winner may not charge any Guest for participating in the prize. Disney, its parent, related, affiliated and subsidiary entities and their respective officers, directors, agents, employees and assigns will be released and discharged from any and all legal claims, losses, injuries, demands, damages, actions, and/or causes of actions that arise out of and/or are in any way related to the prize, the receipt, use and/or enjoyment of the prize, or prize-related activity including travel, the Contest. All disputes arising out of or relating to any prize provided by Disney shall be resolved by applying the laws of California, without regard to conflict of law rules, and shall be solely and exclusively brought in state or federal courts within Orange County, California. Such claims shall be resolved individually, without resort to any form of class action, and all such claims shall be limited to actual out-of-pocket costs incurred, but in no event to include attorneys’ fees. In the event, the winner(s) and any guest(s), if applicable, must comply with any and all COVID-19 vaccination, screening, testing, safety and related requirements imposed or required by (if applicable) the Station, the venue, event promoter, sponsors, travel providers, hotels, governmental authorities or others in connection with the receipt, use, and redemption of the prize. All cancellations are deemed beyond the control of the Station and its sponsors. This includes, but is not limited to, event cancellations due to any pandemic or epidemic constituting a public health emergency, including such public health

emergencies subject to government-mandated quarantines, travel restrictions, or stay-at-home orders. The Station and/or its sponsors shall in no way be responsible under any circumstances whatsoever for replacing, and/or for reimbursing any winner(s) with any form of compensation for, any prize(s) or portion(s) thereof forfeited due to the refusal of the winner(s) and/or their guest(s) to comply with all applicable COVID-19 requirements and/the cancellation of any event, nor will any alternate prize(s) be provided.

9. The odds of being the designated caller depend on the number of attempted calls being made into the studio at the time the designated caller is solicited. Callers are taken in the order they are received into the studio. The odds of a designated caller selecting a winning square are 5 in 100 or better (depending on how many other squares were previously selected and whether a particular caller has knowledge of the prizes associated with those squares).

11. Callers must be fourteen years of age or older; provided that if the winner is between 14 and 18 years of age, his/her parent or legal guardian will be recognized as the winner.
