

ROAD TO STAGECOACH **CONTEST RULES**

These contest rules are specific to the above contest conducted by Audacy San Diego, LLC d/b/a KSON-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the Road to Stagecoach (the “**Contest**”). A purchase or payment will not increase your chance of winning.

From 12:00 AM PT on September 6, 2021 through the earlier of either at on December 3, 2021 or the point at which 150 has been awarded in this Contest, whichever is sooner, go to www.kson.com/contests, click on the link to enter this Contest, and complete the entry form with all applicable and required information.

How to Win

This Contest shall commence at 6:40 AM PT on September 13, 2021 and conclude on the earlier of either at 4:40 PM PT on December 3, 2021 or the point at which 150 has been given away in this Contest, whichever is sooner. Each weekday (Monday through Friday only, excluding holidays) at approximately 6:40 AM PT, 8:40 AM PT, 1:40 PM PT, and 4:40 PM PT, the Station will randomly select one (1) entry from among all eligible entries received through the time of such drawing, and announce the name and town/city of residence of the entrant who submitted such selected entry.
