Comes now the undersigned complainant, being duly sworn upon oath, and under penalties of perjury, and states that there is probable cause to believe that the above-named defendant committed the following crime(s):

**COUNT: 01 STATUTORY SODOMY - 2ND DEGREE - CLASS D FELONY**

That Harry Hamm , in violation of Section 566.064, RSMo, committed the class D felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about April 17, 2019, in the County of St. Louis, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of himself, knowingly had deviate sexual intercourse with A.R. and at that time A.R. was less than seventeen years of age and the defendant was twenty-one years of age or older.

**COUNT: 02 INCEST - CLASS E FELONY**

That Harry Hamm , in violation of Section 568.020, RSMo, committed the class E felony of incest, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about April 17, 2019, in the County of St. Louis, State of Missouri, the defendant engaged in deviate sexual intercourse with A.R. whom the defendant knew to be a descendant by blood.

**COUNT: 03 POSSESSION OF CHILD PORNOGRAPHY - CLASS D FELONY**

That Harry Hamm , in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable upon conviction under Sections 573.037, 558.002 and 558.011, RSMo, in that on or about April 17, 2019, in the County of St. Louis, State of Missouri, the defendant knowingly possessed child pornography that consisted of images of children less than 18 years of age partially and completely nude in sexual positions displaying their genitals.
