KRTH - KNOCK KNOCK IT'S A K-EARTH XMAS 2019 Official Rules

These Contest rules are specific to the above Contest conducted by Entercom California, LLC d/b/a KRTH-FM ("Station"). Except to the extent specifically set forth below with respect to this specific Contest, Station's general contest rules apply to this Contest as well. BY ENTERING THIS CONTEST, NOMINATORS AGREE TO INDEMNIFY AND HOLD HARMLESS STATION AND ITS AFFILIATED COMPANIES AND EMPLOYEES FROM AND AGAINST ANY CLAIM BY ANY PERSONS RELATING TO THE CONTENT OF THE ESSAY AND WISH LIST SUBMITTED BY THE NOMINATOR.
- 3. By submitting an Entry, Nominators and Nominees understand and agree that Station may elect to use any submitted Entry for entertainment purposes on-air and may choose to "make fun" of any submitted Entry. Nominators and Nominees waive any right to

make any claim against Station, or any Contest sponsors with respect to any disparaging comment made on-air about an Essay or Wish List submitted by a Nominator, or in which the Nominee was the subject.

- 4. Essays submitted as Entries in this Contest must be original works created by the person submitting such Entry. In the event it comes to Station's attention before or after Winner selection in this Contest that any such Entry includes any plagiarized material, such Nominator and the affected Nominee shall be disqualified and any and all prizes will be forfeited.
- 5. Failure to submit all of the above items in one (1) Entry will result in disgualification.

How to Win

On or about December 4, 2019, Station judges will review and judge all potential Entries in consideration at such time (as described in Section 2 above), based on any lawful criteria they deem desirable, and select up to one (1) Nominee as a Winner, subject to verification of eligibility and compliance with the Contest Rules (the "Winner"). Starting on December 4, 2019 and ending on or about December 18, 2019, the Station will share the Winner's story, share the Winner's Wish List, and ask the community for donations to fulfill the Winner's Wish List. On December 19, 2019, approximately between 6:00am (PT) and 9:00am (PT) the Station will deliver the Prize to the Winner. Winner does not need to listen to Station to win but must be present when the Station delivers the Prize to a location to be mutually agreed upon by the Station and the Nominator. The Station will contact the Nominator and coordinate Prize delivery on behalf of Winner.
