

CBS-FM's SONG OF THE DAY Contest Rules

These Contest rules are specific to the above Contest conducted by Entercom New York, LLC d/b/a WCBS-FM (collectively, the “**Station**” or “**CBS-FM**”). Except to the extent specifically set forth below with respect to this specific Contest, the Station’s general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station’s general contest rules are available at the Station’s studio at 345 Hudson Street, 10th Floor, New York, NY 10014 during regular business hours and on the Station’s website at www.wcbsfm.com/rules. **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.**

Entry/Winning

1. No purchase necessary to enter or to win the Song of the Day Contest (the “**Contest**”).
2. Listeners can participate in the Contest by listening to the Station weekdays (Monday – Friday) at approximately 7:10am (ET) starting on Monday, December 2, 2019 and ending on Friday, December 13, 2019 for the announcement of the CBS-FM Song of the Day. A different song will be announced each weekday. Once you know the CBS-FM Song of the Day, enter by listening weekdays from between 8:00am (ET) and 7:00pm (ET) beginning on Monday, December 2, 2019 and ending on Friday, December 13, 2019 for the cue to call (CBS-FM Song of the Day). Upon hearing **the song played in its entirety**, be caller number 101 at 1-800-367-1101 and upon verification of eligibility, become a “**Winner**” and receive one (1) Prize.
 - a. Up to a total of ten (10) Winners will be selected in the Contest.

 - c. **Only those calls to the Station’s specific phone number provided at the time calls are solicited shall be eligible to win. Calls to the main Station phone number or any other phone number shall not be accepted for entry to this Contest.**

Prize(s)

3. The odds of winning depend on the number and order of calls received.
4. Up to ten (10) “**Prizes**” will be awarded in this Contest. Each Winner will receive a four (4) day, three (3) night trip for Winner and one (1) “**Guest**” to Universal Orlando Resort in Orlando, Florida (“**Trip**”), with a Fair Market Value (“FMV”) of \$1,978.64 per Prize, courtesy of Universal Orlando (as defined below). Trip will include: (i) round trip economy class air transportation for Winner and one (1) Guest from a major commercial airport near Winner’s home (as determined by Universal Orlando in their sole discretion) to Orlando, FL; (ii) three (3) nights standard hotel accommodation (one room, double occupancy, room and tax only) at Universal’s Endless Summer Resort – Surfside Inn and Suites or at another Universal Orlando Resort hotel (as determined by Universal Orlando in their sole discretion); (iii) non-exclusive ground transportation to and from airport and hotel in Orlando, FL; (iv) two (2) 3-Park 3-Day Park-to-Park theme park tickets for admission to Universal Studios Florida and Universal’s Islands of Adventure theme parks and Universal’s Volcano Bay water theme park for Winner and one (1) Guest; and (v) admission to one (1) Blue Man Group Show (exact date and time to be determined by Universal Orlando in its sole discretion).
5. **Trip must be taken by Sunday, December 22, 2020 or Prize will be forfeited.** Travel dates and arrangements are subject to availability. Blackout dates or other restrictions may apply as



dictated by airlines and/or hotel. Travel dates are subject to Universal Orlando and Station approval. Reservations are subject to availability. Trip must be booked at least sixty (60) days prior to intended departure date. If a Winner elects to partake in any or all portions of his/her Prize with no Guest, the Prize will be awarded to Winner only and any remainder of the Prize will be forfeited and shall not be subject to further or alternative compensation. All elements of the Prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption.

6. Winner must be eighteen (18) years of age or older. If Winner is between the ages of eighteen (18) and twenty-one (21), he/she must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the hotel. Unless child or ward of Winner, Guest must be eighteen (18) years of age or older as of the date of departure and must travel on the same itinerary and at the same time as the Winner.
7. FMV of Prize may vary depending upon the points of departure, ground transportation, and/or airline fare fluctuations; any difference between stated FMV and final FMV of Prize will not be awarded. Prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, meals, unspecified ground transportation, phone calls, gratuities, incidentals, souvenirs, gasoline, etc.) are included in the Prize and all such expenses are the sole responsibility of Winner. Winner is responsible for any air travel taxes and/or expenses, including applicable departure taxes or fees, baggage fees, inspection charges, and security charges. Winner and Guest are responsible for obtaining, at their own expense, any necessary travel documentation (i.e. valid photo identification, visas, passports, etc.) prior to travel. Once issued, tickets are nontransferable and may not be reissued once travel has commenced. Open tickets may not be issued and stopovers are not permitted. Some special events may be separately ticketed. Universal Orlando reserves the right to change the name of all tickets. All tickets specifically exclude admission to special or separately ticketed "hard ticket" entertainment events at any of the theme parks, hotels, or within any of the Universal CityWalk venues such as Hard Rock Live and the Blue Man Group show.
