

V-103/Delta Community Credit Union HBCU Scholarship Contest Official Contest Rules – October 2021

These contest rules are specific to the above contest conducted by Audacy Georgia, LLC d/b/a WVEE ("Station"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this contest as well. A copy of these specific contest rules and the Station's general contest rules are available on the Station's website at <https://www.audacy.com/v103/contest-rules>. **As a preventative measure in light of the COVID-19 (Coronavirus) pandemic, copies of the specific contest rules and the Station's general contest rules will not be available at the Station's studio. To the extent the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

HOW TO ENTER

1. No purchase is necessary to enter or win the V-103/Delta Community Credit Union HBCU Scholarship Contest (the "**Contest**"). A purchase or payment will not increase your chance of winning.
2. Entrants must be 17 years of age or older and legally reside in Georgia as of the date of entry in this Contest (each an "**Entrant**"). In the event that a prize is won by an entrant who is under 18 years of age, for all purposes under these rules, the parent or legal guardian may be recognized as the actual winner of the prize for tax and liability purposes although only the student may utilize the prize. Entrants must also be currently enrolled students at a Georgia Historically Black College or University or be accepted to a Georgia Historically Black College or University ("**Georgia HBCU**") in 2021 or 2022. For purposes of this contest, the HBCUs in the state of Georgia are as follows: Albany State University, Clark Atlanta University, Fort Valley State University, Morehouse College, Morris Brown College, Paine College, Savannah State University and Spelman College.
3. To enter from 6:00am (ET) on Monday, October 4, 2021 through 12Noon (ET) on Friday, October 29, 2021, visit v-103.com/contests, click on the V-103/Delta Community Credit Union HBCU Scholarship Contest link and complete the online entry/registration form by submitting the entrant's full name, phone number (including area code), age, e-mail address, and a short essay of one-hundred and fifty (150) words or less describing why Entrant believes they deserve to win the Prize (*as described in Section 7 below*).
 - a. Essay should be one-hundred and fifty (150) words or less. Entries with an essay comprised of more than one-hundred and fifty (150) words will not be disqualified, but only the first one-hundred and fifty (150) words will be read and considered for the Contest.
 - b. Essay need not be truthful. Station will not verify the truthfulness of the information submitted in each entry; provided, however, that failure to satisfy (or suggestion that you fail to satisfy) the entry eligibility requirements or other Contest rules applicable to this Contest can result in disqualification of the Entrant from becoming the Grand Prize Winner, in Station's sole discretion.
 - c. Station reserves the right, but is under no obligation, to edit an Entrant's essay in any manner that it chooses at Station's sole discretion.
 - d. The entry/registration process may require you to either log into an existing account, or create a free account with the game administrator, Aptivada. You may either elect the option to have your Facebook profile pre-load applicable portions of the entry form (Facebook account is not required to enter this Contest), or complete the online entry/registration form by submitting the Entrant's full name, address of legal residence, phone number (including area code), age, username (subject to acceptance by Contest software to eliminate duplicate usernames), password, e-mail address, and other information requested (some of which may be optional).
 - e. Limit one (1) Aptivada account per email address. Limit one (1) entry per Aptivada account.
 - f. As part of the entry process, Entrants may be provided with an opportunity to opt-in to receive solicitations from Delta Community Credit Union, and/or to become a member/participate in clubs of (i.e., email clubs, and rewards programs), the Station; provided, however, agreeing to receive such solicitations and/or accepting such membership is not a condition of entry into this Contest and will not increase your chances of winning.
4. By entering this Contest, Entrants certify that any information contained in the essay/explanation does not contain any defamatory or indecent material. By submitting an Entry in this Contest, each Entrant authorizes the Station to post such essay and/or Entrant's name to the Station's website or to read it on-air in whole

or in part. Station reserves the right to edit an Entry in its sole discretion. Not all entries will be posted to the Station's website and/or read on-air and in the event that Station posts or read any such Entry it does not mean that such Entry has won or may be selected to win any prize in this Contest.

5. By entering this Contest, Entrants understand and agree that Station may elect to use any Entry submitted for entertainment purposes and may choose to comment on, mock, poke fun at, and/or mimic any Entry submitted. Entrants waive any right to make any claim against Station with respect to any comments – disparaging or otherwise – made regarding such Entrant's Entry.

HOW TO WIN

6. On or about day, October 29, 2021 Station and Delta Community Credit Union judges will review up to the first one-hundred and fifty (150) words from all eligible entry essays received, and select up to one (1) winner, subject to verification of eligibility and compliance with these Contest rules (the "**Winner**").
 - a. The Station will notify the potential Winner of winning by means of the phone number and/or email provided by Entrant at time of Contest entry no later than November 5, 2021.
 - b. Notification to potential Winner may be made by message on the Entrant's voicemail, with no responsibility for any failure of the voicemail at the Entrant's phone number provided on the entry form.
 - c. Station reserves the right, but is not obligated, to attempt to contact the Winner on one or more occasions or on one or more phone numbers provided.
 - d. In order to be selected as a Winner, potential Winner must, in addition to all other eligibility requirements, respond to the Station's notification within twenty-four (24) hours of notice or attempted notice.
 - e. As a condition of receiving any prize, the Winner (or parent/legal guardian for any Winner under the age of majority) is required to complete an affidavit of eligibility and a liability and publicity release (except where prohibited by law), which must be signed at the time the Winner claims their Prize. Failure to sign the affidavit or release may, at the sole discretion of the Station, result in a Winner's disqualification and forfeiture of the prize.

PRIZE

7. Up to one (1) prize will be awarded in this Contest. The verified Winner will receive a check from Delta Community Credit Union paid directly to the Georgia HBCU toward the Winner's school account in the amount of \$2,500.00, valued at \$2,500.00 and courtesy of Delta Community Credit Union (the "**Prize**").
 - a. Prize is subject to the requirements, restrictions, availability and limitations described in these Contest rules.
 - b. **WINNING THE PRIZE DOES NOT ENSURE COLLEGE ADMISSION.** Winning the Prize does not impact whether a Georgia HBCU will grant admission to the Winner. The Station has no responsibility for the Winner's admission or rejection. However, if the Winner is admitted to a Georgia HBCU in accordance with these rules and does in fact enroll/register for any applicable semester listed above, he/she will be deemed an "Eligible Student".
 - c. This Prize will be subject to class availability and other restrictions (including without limitation entry exams or prerequisites for certain classes). Winner will receive no credit nor cash compensation for any portion of the Prize that remains unused for any reason. Prize is only redeemable by the verified Winner in accordance with these rules.
8. **Prize will be forfeited if the selected Winner does not provide proof of admission or enrollment at a Georgia HBCU or does not satisfy the eligibility requirements or other requirements set forth in these Contest rules.**
9. **If Prize is forfeited, the Station reserves the right (but not the obligation) to pick an alternate Winner from among all other entries, time permitting.**
10. **THIS PRIZE MAY BE TAXABLE AND THE WINNER IS SOLELY RESPONSIBLE FOR PAYING ANY TAX OWED ON THIS PRIZE.**

SPONSORS

11. The sponsor of this Contest is Audacy Georgia, LLC.

OTHER RULES

12. By participating in this Contest, each Entrant hereby consents to the Company's use of following in all media and for advertising and promotional purposes without payment of additional consideration: Entrant's name; voice; likeness; biographical information; Essay, his/her participation in the Contest; and the substance of the Entrant's telephone call. Entrant agrees that no additional compensation will be paid for such usage.
13. Station is conducting this Contest using proprietary software owned by a third party known as Aptivada Inc. ("Aptivada"). Aptivada is not a sponsor of this Contest but entrants may be required, as part of the entry process, to agree and consent to Aptivada's Terms of Service and Privacy Policy (both of which are available via a link during the Contest entry process) (collectively, the "Aptivada Policies") and may be required to register with Aptivada. While agreement to the Aptivada Policies is required in order to enter this Contest, the Aptivada Policies are not a part of these Contest rules but are a separate agreement between the entrant and Aptivada. With respect to the conduct of this Contest by Station, in the event of any conflict between the Aptivada Policies and the Station Contest rules, the Station's Contest rules govern.
14. Station is not responsible for any error or technical malfunctions associated with the Aptivada site that may affect any entrant's ability to enter, to win, or to be properly considered in this Contest, regardless of the cause. In the event of a malfunction associated with the Aptivada site that Station (in its sole discretion) deems to materially and adversely affect this Contest, Station reserves the right to suspend this Contest, terminate this Contest without a winner, terminate this Contest and select a winner early, provide alternative means of entry or any other changes to these Contest rules that Station deems appropriate under the circumstances. Any such changes, terminations or suspensions will be announced on air and/or posted on the Station's website, if applicable.
15. Employees of Aptivada and its affiliates, their respective parents, affiliates, subsidiaries, advertising sponsors and promotional agencies, and the immediate family members of each are not eligible to win in this Contest.
