LRS: 14:80 titled FELONY CARNAL KNOWLEDGE OF A JUVENILE, 14:81 titled INDECENT BEHAVIOR WITH JUVENILES, & 14:92 titled CONTRIBUTING TO THE DELINQUENCY OF JUVENILES (2 cts.)

The Affiant informs the Court that within the State of Louisiana and Parish of East Baton Rouge, the Accused, Ellarea Breedlove Silva (w/f 06-27-1985), did violate LRS 14:80, titled Felony Carnal Knowledge of a Juvenile, to wit ,the Accused had sexual intercourse, with consent, with a person older than 13 years of age and under the age of 17, where the age difference between the victim and the age of the offender is four years or greater, LRS 14:81, titled Indecent Behavior with Juveniles, to wit, any lewd or lascivious conduct, text, words, or images to any person believed to be under the age of seventeen and reasonably believed to be

at least two years younger than the offender, and (2) counts LRS 14:92, titled Contributing to the Delinquency of Juveniles with the intentional enticing, aiding, soliciting, or permitting, by anyone over the age of seventeen, of any child under the age of seventeen, to perform any sexually immoral act and absent himself or remain away, without authority of his parents, from his home.

On January 27, 2020, East Baton Rouge Sheriff's Office (EBRSO) General Investigations Detectives were notified by a Zachary Police Department (ZPD) Detective of an inappropriate relationship between a teacher and student. The Detective stated during his investigation a forensic interview was conducted with the juvenile Victim at the Baton Rouge Children's Advocacy Center. During the interview, the Victim disclosed that he was engaged in a consensual sexual relationship with one of his teachers, the Accused, in 2019.

The Victim further disclosed the Accused initially contacted him by sending a message using her school email address to his student email address. Over a period of time, the Victim and the Accused exchanged personal email accounts so the school could not track their emails. Using these personal email accounts, the Victim stated the Accused sent nude photographs and nude videos of herself to him. The Victim stated the Accused intentionally avoided capturing her face in the photographs and videos. Additionally, the Accused gave the Victim her cellphone number and sent a text message indicating she wanted to have sexual intercourse with him.

The Victim stated after texting the relationship became physically sexual at an unknown time before the summer of 2019. During the summer months of 2019, the Accused picked up the Victim at his residence in Zachary, LA, and brought him, without parental consent, to her residence. Affiant notes the Accused's residence is located within East Baton Rouge Parish. Once at the Accused's residence, the Victim stated the Accused gave him a pink E-cigarette vaping device which contained what the Victim described as the chemical substance tetrahydrocannabinol (THC). The Victim recalled having consensual intercourse approximately 8 to 9 different times during the summer of 2019 with the Accused at her residence. The Victim also stated the Accused's minor child was present at her residence during each incident. During the summer of 2019, the estimated age of the Accused was 34 and the age of the victim was 15.

After the Victim decided to disclose his relationship with the Accused, the Accused and he exchanged additional text messages. The Accused asked the Victim not to disclose due to how his disclosure would affect her career and her family.

Affiant requests an arrest warrant for the Accused in reference to this matter.

Affiant certifies under oath that the information contained herein to be true and correct to the best of my knowledge under penalties of perjury and request that a warrant of arrest of the accused be issued.
